

Copyright and Trademark License Agreement (“Agreement”)

All use of Literature, as that term is defined below, shall be governed by the following terms and conditions:

1. Definitions.

- a. **“Commercial User”** shall mean persons affiliated with or acting on behalf of Original Equipment Manufacturers (OEMs), retailers, service and rental businesses, and other commercial buyers.
- b. **“Individual User”** shall mean individual end-consumers who purchase a KOHLER® product, or a product that incorporates a KOHLER® engine or part.
- c. **“Licensee”** shall collectively refer to Commercial Users and Individual Users.
- d. **“Literature”** shall mean KOHLER® engine and parts manuals, and other documentation and materials made available by Kohler through its website.

2. Kohler’s Intellectual Property Rights. Licensee acknowledges and agrees that Kohler owns all copyrights in the Literature worldwide, and all rights and registrations in the trademarks incorporated in the Literature worldwide.

3. Grant of Copyright License – Individual User. Subject to the terms and conditions of this Agreement, Kohler hereby grants, and by downloading Literature Individual User accepts, a limited, non-exclusive license to use the Literature for Individual User’s own personal use, and the same shall not be copied, distributed, modified, sold or used for any other purpose.

4. Grant of Copyright License – Commercial User. Subject to the terms and conditions of this Agreement, Kohler hereby grants, and by downloading Literature Commercial User hereby accepts, the limited, non-exclusive right to use, copy and distribute the Literature, and to a limited degree prepare derivative works that incorporate the Literature, solely in connection with the sale of products that incorporate KOHLER engines or parts. The limited right to prepare derivative works incorporating the Literature shall only allow Commercial User to affix its company name and/or logo (“Your Marks”) to the Literature, and shall not include the right to edit Literature, or extract portions of Literature for inclusion in another work. Your Marks must be displayed relative to any KOHLER trademarks in a manner consistent with the KOHLER Brand Guidelines or in another manner authorized in writing by Kohler (the “Approved Works”). **Any use of the Literature in a manner inconsistent with this section and/or beyond the scope of the Approved Works shall require a separate written license granted by Kohler, and may be requested by contacting Kohler at: Enginefieldservice@kohler.com.**

To the extent the Approved Works constitute a derivative work under the copyright laws in any country, the derivative work and any copyright therein shall be owned by Kohler.

5. Grant of Trademark License. Subject to the terms and conditions of this Agreement, Kohler hereby grants to Commercial User the limited, non-exclusive right to use Kohler’s trademarks, including the KOHLER name and logo, and other marks incorporated in the Literature (the “Licensed Marks”) only in connection with the Literature and Approved Works. Kohler makes no representations or warranties with respect to the Licensed Marks and licenses the Licensed Marks “As Is.” **KOHLER HEREBY DISCLAIMS ANY AND ALL WARRANTIES, WHETHER STATUTORY, EXPRESS, OR IMPLIED, INCLUDING WITHOUT LIMITATION**

THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS.

6. Modification of the Literature. Kohler may modify and revise the Literature as necessary or desirable. Commercial User (i) shall only use and distribute the most recent version of the Literature supplied by Kohler, (ii) shall not modify the Literature other than to create Approved Works in accordance with Section 4 of this Agreement, (iii) shall not modify, omit or redact any portion of the Literature, including any Licensed Marks or copyright notices, and (iv) shall not affix any text, trademarks or logos to the Literature other than Your Marks.
7. Termination. Kohler may terminate this Agreement at any time if Licensee fails to comply with the terms and conditions set forth herein. Upon termination, Licensee shall immediately cease and desist all use of the Literature and Approved Works, shall refrain from downloading the Literature and shall destroy any and all electronic or print copies of the Literature and Approved Works and provide Kohler with written certification that it has done the same.
8. Merger and Integration. This Agreement constitutes the entire understanding of the parties with respect to the subject matter hereof and supersedes all prior agreements or understandings, whether written or oral, relating to the subject matter hereof.
9. Governing Law; Dispute Resolution. This Agreement shall be governed by the laws of the State of Wisconsin, United States of America. The venue for any and all disputes arising out of or relating to this Agreement shall be either the Milwaukee County Circuit Court for the State of Wisconsin or the United States District Court for the Eastern District of Wisconsin. Kohler and Licensee consent to personal jurisdiction and venue in such courts.
